IDENTIFICATION DOCUMENTS:

Landlords are required to keep clear and legible copies for the period of the tenancy and for a year after the tenancy has come to an end (s5 of The Immigration (Residential Accommodation)(Prescribed Requirements and Codes of Practice) Order 2014). At the time of writing the government guidance states that if the following documents are provided no follow up checks are required.

Group 1

- A current or expired British passport
- A current or expired European Economic Area (EEA) or Swiss passport or national identity card •
- A current or expired registration Certificate issued by the Home Office to an EEA/Swiss national
- A current or expired document issued by the Home Office to an EEA/Swiss national certifying permanent residence
- A current or expired permanent residence card or document issued by the Home Office to the family member of an EEA/Swiss national

indicating permanent residence

- A current or expired biometric residence permit which indicates the holder as no time limit to stay on their stay in the UK
- A current or expired passport or other travel document endorsed to show that the holder is exempt from immigration control or entitled to reside in the UK with no time limit
- A valid immigration status document containing a photograph which with endorsement that person named has no time limit to stay in UK
- A certificate of registration or naturalisation as a British citizen.

Group 2

- A summary or full UK, Channel Islands, Isle of Man or Ireland birth or adoption certificate
- A letter issued within the last 3 months confirming the holder's name, issued by a UK government department or local authority and signed by a named official (giving their name and professional address), or signed by a British passport holder (giving their name, address and passport number), or issued by a person who employs the holder (giving their name and company address) confirming the holder's status as an employee
- A letter from a UK police force confirming the holder is a victim of crime in which a document from Group 1 (above) has been stolen, stating the crime reference number, issued within the last 3 months
- Evidence of the holder's previous or current service in any of HM's UK armed forces
- A letter from HM, Scottish and/or Northern Ireland Prison Service, confirming the holder's name, date of birth, and that they have been released from custody of that service, issued in the past 3 months
- A letter from an officer of the NOMS in England or Wales or Probation Board for Northern Ireland confirming the holder's name, date of birth and that the holder is the subject of an order requiring supervision by that officer issued within last 3 months
- A letter from a UK higher education institution confirming the holder's acceptance on a course of studies

The sign of succ

- A Disclosure and Barring Service certificate issued within the last 3 months
- A document or screen shot of an electronic document issued within last 3 months from either HMRC, DWP, DSDNI or Local Authority confirming holder entitled to benefit.
- A letter issued within last 3 months by public authority, voluntary organisation or charity in the course of a scheme operated to assist people to secure accommodation or to resolve homelessness. This must include holders name and address of a prospective tenancy that they are assisting the holder to obtain

TIME LIMITED RIGHT TO REMAIN IN THE UK:

Time limited right

At the time of writing, if one of the following documents are provided showing the holder or named person is allowed to stay in the UK for a **time limited period** the government guidance states that the landlord can accept such documents but the landlord must carry out follow up checks after one year, beginning with the date on which the checks were last made, or before the expiry of the person's permission to be in the UK (whichever is longer) or on the expiry of a person's permission to stay in the UK as shown on their biometric residence permit:

- A current passport or other travel document endorsed with a time-limited period
- A current biometric immigration document issued by the Home Office which indicates person named is permitted to stay in UK with time-limited leave
- A current residence card or document issued to a non-EEA national who is a family member of an EEA/Swiss national or has a derivative right of residence
- A current immigration status document issued by the Home Office with a valid endorsement indicating that the holder has been granted limited leave to enter, or remain in the UK
- Where the person has an ongoing application with the Home Office, or their documents are with the Home Office, or they claim to have a permission of right to rent, an email from the Landlords Checking Service providing a 'yes' response to a right to rent request.
